eBooks & eAudiobooks Available for Check-Out

If you haven't heard, we have eBooks and eAudiobooks (so called to distinguish them from Audiobooks on CD, which we also have) are available for check-out with your library card and password. Don't have a library card or don't know your password? Call us at (662) 843-2774 x 109 to find out what you need to get your library card and password.

You have the option of using the Axis360 Mobile app or the Read Now app on your PC. For the mobile app, go to your chosen app store and download the Axis360 Mobile app onto your device. The first time you log into the app you will have to enter your library card number (the barcode on the back of your card that you enter without spaces) and your password. As long as you don't log out, you will not have to enter this again. For the Read Now app, use your PC to access the Magic Wall from our website, login using your library card number and password, check out a book, and then choose the Read Now option to read from your PC.

You may check out up to three titles at a time and keep them for three weeks. You have the option of returning a title early if you are finished reading it or just do nothing and it will "expire" when the check out period ends. The advantage of returning early is that within a few hours of returning a title you can check out another title.

We have over 700 eBooks and over 70 eAudios for your reading pleasure. And, just like other materials, you may request that we purchase a specific title. We can't promise we will purchase every item requested, but we evaluate all requests and will notify you about our decision.

Storyhour via Zoom and First Library Cards

Did You Know?

Did you know that you can check out materials (books, audiobooks, DVDs, etc.) from any branch of the Bolivar County Library System (BCLS) and return your materials to any branch of the Bolivar County Library System? Yes, if you have a BCLS library card in good standing, you may check out and return materials to any of the four BCLS branches in Cleveland, Merigold,

Rosedale, or Shelby.

Did you know that you can request that we consider purchasing any type of materials that we currently have collections for? Yes, you may request we consider purchasing an item you would like to read (or watch) that we don't currently own in the format you desire—print books, eBooks & eAudiobooks, Audiobooks on CD, and DVDs. We can't promise to

purchase everything that our patrons request, but if we don't purchase a requested item, we will make every effort to borrow the item from another library through the Inter-Library Loan (ILL) Program. If we borrow an item through ILL, we will notify you when it is available to pick-up at the branch of your choice and when you are finished, just return it to any BCLS branch.

Looking for a Good Book?


Anna: Memoirs of a Geisha by
Arthur Golden. Wildly popular,
this is a timeless story of love,
perseverance, and destiny, and it
more than earns its distinction as
a modern classic. Set in Kyoto,
Japan, this sweeping tale follows
Chiyo, a poor fisherman's daughter who greatly improves her
station, eventually assuming one of
Japan's most esteemed roles for
women—a geisha. This novel will
have you captivated from the first

page, especially as Chiyo immerses herself in the rich culture and intricate customs of Kyoto's geisha district, Gion. This is a great read for anyone who loves historical fiction. (Fiction—Print)

Tamara: Devolution: A Firsthand Account of the Rainier Sasquatch Massacre by Max Brooks, author of World War Z. Despite the title, this is a work of fiction and it was so good! The story opens with the

troubled Holland family joining the Greenloop community, six state-of-the-art "green" homes— just before the catastrophic eruption of Mt. Rainier. Cut off from civilization, the group must work together to survive, first from starvation, then from an enemy no one expected. The dread is palpable in this thrilling page-turner. I highly recommend this to anyone who enjoys horror and suspense. (Fiction—Print & eBook)

Some Bolivar County History...

This continued excerpt is taken from the chapter titled "The Creation of Bolivar County" and the section titled "Early Settlers" that begins on Page 6 that details the plantations and their owners. The chapter was written by Walter Sillers.

The final sentence from the last newsletter ended: "... the Alexanders, the Masons, the Parkers, the Carsons, the Hudsons, the Branders, the Shelbys, and the Gozas."

"Among these early settlers were many prominent men, such as Colonel Charles Clark, a colonel in the Mexican War; General A.B. Bradford, who was a major in the Mexican War; Captain F.A. Montgomery, Lieutenant Clinton D. Herndon, a major of the Confederacy; Judge William L. Harris of the Supreme Court of Mississippi, who owned a plantation on Bogue Phalia; and his son-in-law, Dick Bell, who was sheriff before the war, and later a lieutenant in the Bolivar Troop. Bell was a nephew of John A. Bell, the last Whig candidate for president. Then there were Major Andrew Jackson Donelson, a typical Southern gentlemen; Major W.E. Montgomery, Dr. D.C. Montgomery, Captain Gadai Herrin of the Bolivar Troop, who was killed in a charge at Franklin; James S. Peacock, author of the "Creole Orphans" and other novels; Judge Joseph McGuire, first probate judge of the county; Judge Charles T. Miles, probate judge; Judge John Burrus, Judge Shawl Yerger, a planter and judge of the circuit court before the war; Judge B.F. Trimble and Judge Poindexter, attorneys before the War; and Isaac S. Robinson, clerk of the circuit court before the War. George L. Gayden, Miles McGehee, Samuel Lee, Joseph Sillers, John Lobdell, Gilford Torrey, Colonel C.I. Field, Isaac Hudson, J.M. Owen, George Walton, and others, all personally known to me, and the many others not known to me, were men of prominence in the building of the county before the War, and in defending it during the War."
