## BCLS Administrative Board of Trustees Change

Recently, BCLS was saddened to say farewell to Administrative Board of Trustee member John Raymond Bassie, a representative of District 2 whose term expired



in December. Mr. Bassie joined the Board in April 2007 when he took over Ann Koonce's term.

which was set to expire in December 2010. Mr. Bassie then went on to complete two fiveyear terms, the maximum allowed by law. A staunch library supporter, Mr. Bassie served as Board vice-chair from 2009-2016 and secretary from 2017–2020.

As you may know, the Board of Supervisors created and empowered the BCLS Board of Trustees in 1958. When a vacancy occurs, the Supervisor from that district selects someone from their district to fill the vacancy on the Board. Their choice is then approved by the full Board of Supervisors. The five Board members have staggered terms so that only one member's term expires per year. Any resident of Bolivar County may serve on the Board and anyone interested in doing so may contact the Supervisor in their district to let them of their interest in serving.

We are pleased to welcome the new District 2 representative to the Board of Trustees, Gunnison native Ms. Lynn Shurden, who joined the Board as of January Ist, Ms. Shurden is not new to the library world. She completed her Masters of Library and Information Studies at the University of Southern Mississippi in 1994 and BSE in Volume XV, Issue I

Library Science from DSU in 1978. She worked at the library at Parchman State Penitentiary for



nine years, was a senior library consultant for the Mississippi Library Commission from 1985 through 2006,

and was the BCLS director from 2008 until her retirement in 2013. She continued her library service by joining the Friends of the Bolivar County Library System Board in 2016 and was the president of that group from 2018 -2019. In 2019, she stepped in as the interim director of BCLS until the current director Emily Bell began in June of 2019. Ms. Shurden is also a Master Gardner, chair of Cleveland Heritage Commission, and Membership Chair for Delta Arts Alliance.

# Mississippi Humanities Council's Anti-Racist Reading Shelf Grant

We are pleased to announce that the library system is the recipient of an Anti-Racism Reading Shelf grant in the amount of \$1,000, which the Friends of the Bolivar County Library System will be matching. The grant was awarded October 1, 2020 by the Mississippi Humanities Council (MHC), and grant funds will allow for the purchase of books related to the history and experience of racism, as well as other expenses associated with the purchase, ordering,

processing, and cataloging of the books.

The grant was created by MHC with financial support from Mississippians and the National Endowment for the Humanities. MHC worked with humanities scholars and project partners at the Mississippi Library Commission to create a suggested list of books for all ages from which grant recipients could choose. The suggested list includes many award winning and critically acclaimed titles that explore the history of racism and encourage the building a racially equitable society.

To further publicize the Anti-Racism Reading Shelf, the branches in Cleveland, Rosedale, Shelby, and Merigold will each have a special display that both highlights the books and makes them easily accessible to readers interested in this timely topic. 
## Curbside Service

# Eagle Scout Holt David Fortner & Troop 23 Install New Bike Rack




### Virtual Storyhour and Activity Packets

#### "OTHER LETTERS" [ADDRESSED TO MISS NANCY STEPHENS, EVANSVILLE, INDIANA]

My Ever Dear Sisters:

"Mississippi, Bolivar County. August the 20th, 1849

After a long silence, I have the pleasure of addressing you once more, and I sincerely hope that these few lines may find you in better health and spirits that I am at this time enjoying, although I have no great reason to complain, for the Cholera is raging from New Orleans to within five miles of us. I do think that if you knew my anxiety to see you all, some of you would certainly come and see me. When I think of the uncertainty of life, I think that I would be willing to sacrifice everything that I have to see you all once more, but I can delay no longer telling you how happy we are in being blessed with the sweetest babe you ever saw. I wish you could see her little round face.

I suppose you know that Mr. Wilson is overseeing this year for Isaac Wilkerson. He and his wife have been up to Raleigh, Kentucky, ever since we have been here, but he has now returned home and is preparing to start up there after his wife and child. Our time is not out until next Christmas, when we expect to come and see you, if nothing prevents, but our prospects look very bad at present. There is not a acre of land in the country but is under water, but I believe it is falling. Our society is improving, we have several really enterprising neighbors. I could tell you much more if I had time, but mother is almost ready to start and I have a letter to write to brother John. He wrote to me that he intended to come and see me but he never has. Tell Samuel to come this summer if possible.

Farewell, my Dear Sisters, nothing more at present.

S. R. Wilson."

"Dear Eliza:

I would be very glad if you would come down and spend the summer and fall with her (Susan) and she will go up with you this spring and spend a month or two with you all. The water is over everything now, but is falling. It is very discouraging to Susan but we never fail to make a crop.

Nothing more at present, I remain, Your friend. John S. Wilson."
